Faced with this complex scenario, we have the responsibility to double our efforts to promote the defense of the rights of the various groups. On the part of the different levels of government, civil society and the private sector, policies and strategies in favor of these families must be coordinated and articulated beyond living over-regulated and bureaucratically unclassifiable scenarios.

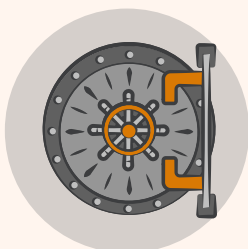

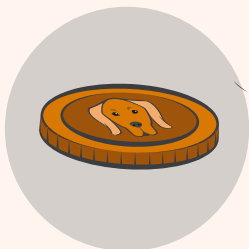


### WALLET

# COMMUNITY GOVERNMENT

## GOVERNING BODY AND MANAGEMENT MODEL

This is a project that was born on the premise of belonging to your community, and based on this premise, the governing body and model of management is capable of offering sufficient guarantee to the project in its most critical stage start-up, subsequent launch, growth and consolidation.

During the first year, the governing body will be made up of its three founders, adding new members to the board of directors until a team of seven people are formed.

All strategic decisions will be taken by the majority whom will vote through the blockchain and all economic transactions will be regulated with a multi-signature system that requires two of the three startup ambassadors to sign, three of the five later and five of the seven in their final stage.

All the funds of the issued token (GRAY) will be protected, in addition to being able to be locked, thanks to the balance blocking and multi-signature tools that we have created, beyond counting on, if necessary, other companies and technology of third parties to guarantee the health of the token and the good governance of the project.

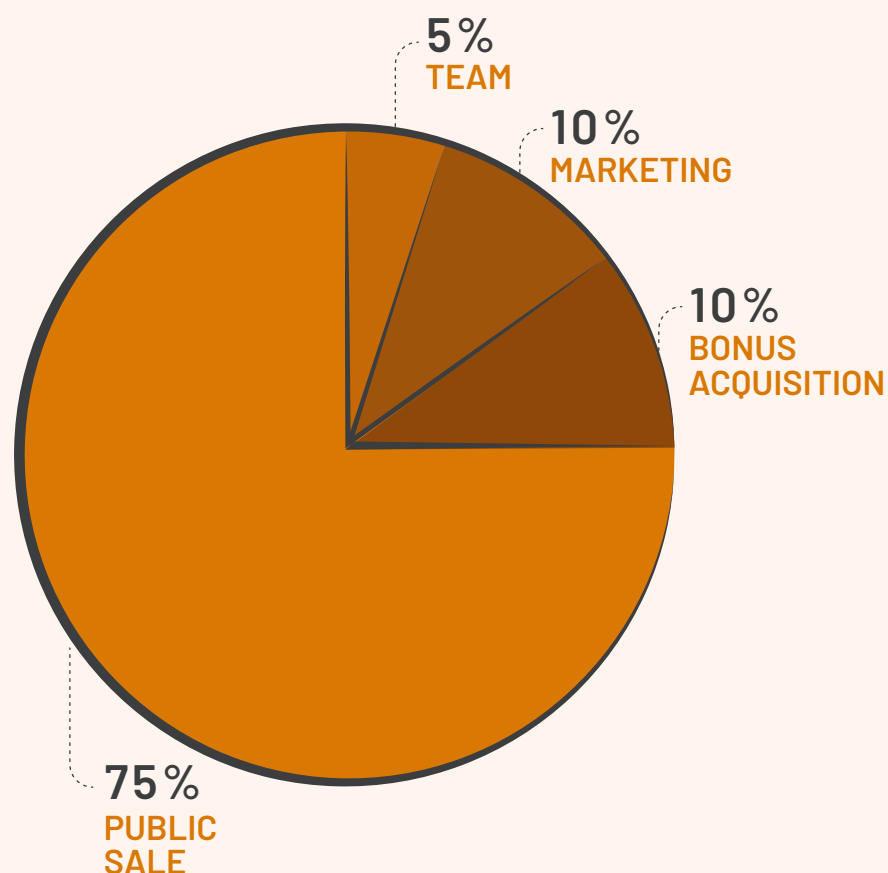
## CONFIGURATION AND DISTRIBUTION OF ISSUED TOKENS

After its issuance, the first liquidity pool has been created and established derived from the above price of the token and its capitalization.

At the time of writing, the token has a value of \$0.000001342 and a capitalization of \$136 million.

The distribution of all the tokens issued is the one that we present to continuation:

It is important to note that the purpose of the token is not to finance constant the project during the following years. The project must work its sources of income, mainly via donations through corporations and people who at an international level decided to help the project and its community.
